Abstract Of Issue: As of February 1 st , 2002, the height requirement of the rides listed above has been changed to 36 inches.	
Reason For Release: Sellner Manufacturing feels that a person 36 inches in height can safely experience the ride without being accompanied by a responsible person.	
Action To Be Taken: Place the number '36' decal given with this notification and place it on the nomenclature statement, supplied with the ride, over the number '42' in the sentence that gives the height requirements. Inform your operators of the change that has occurred. It is important that this document remain in the operation and service manual of your ride.	
Detail Of Issue:	
<div style="text-align: center;"> <p>36"</p> <p>CAUTION</p> <ol style="list-style-type: none"> 1. Watch the ride in operation and make sure you and/or your child can ride it safely. 2. Observe height restrictions and posted rules of the ride. 3. Follow instructions of the ride operator. 4. Keep hands, arms and legs inside the ride at all times. 5. Use proper safety equipment when provided. 6. DO NOT force your child to ride if he or she is frightened. A scared child on the ground may well panic on the ride. 7. To experience this ride you must be at least 42" tall or accompanied by a responsible person. 8. People with high blood pressure, heart trouble, recent surgery or illness, pregnant, under a doctor's care, or under the influence of drugs or alcohol should not experience this ride. 9. People who have back, neck or bone injury or are unable to grasp and hold themselves upright should not experience this ride. 10. No food, drink or smoking on the ride. 11. Adequate footwear must be worn. 12. Stay seated until operator dismisses you. 13. Take care when stepping off and exiting the ride.
