RIDE: GRAVITRON, STARSHIP, ALIEN ABDUCTION AND CENTRIFUGE

SUBJECT: TRAP DOOR

The Gravitron, Starship, Alien and Centrifuge rides are equipped with a trap door accessible from the inside. The purpose of this door has been as an emergency exit.

At the time of original design an emergency exit was required by some State Fire Marshalls as a second means of egress because the ride is totally enclosed during operation, holds more than 40 passengers and should the main door jam closed. Because of this, we installed the trap door. As of last notice this is no longer the case.

The trap door must be locked, bolted or welded shut at all times.

- ❖ **SERIOUS INJURY AND DEATH HAS OCCURRED ON THE RIDE DUE TO STANDING IN THE DOORWAY AS THE RIDE IS TURNED.**
- ❖ **TO PREVENT THIS, PERMINATELY FASTEN THE DOOR CLOSED.**
- ❖ **THIS IS A MANDATORY REQUIREMENT ON THE RIDE.**
